1. EXECUTIVE SUMMARY

1.1 INTRODUCTION

Founded in 2012, Govindlal Kanhaiyalal Joshi (Night) Commerce College holds a significant place in the educational landscape of Latur, Maharashtra. It stands as a private, non-aided institution and affiliated with Swami Ramanand Teerth Marathwada University Nanded, known for its academic excellence.

The establishment of this institution marked a milestone in the Marathwada region as it became the first night college in the area. The visionary behind the formation of this institute is Shri. Dhanrajji Joshi, who recognized the pressing need to provide educational opportunities to individuals who were deprived of higher education due to their employment obligations.

Govindlal Kanhaiyalal Joshi (Night) Commerce College has been acknowledged for its commitment to providing quality education. Its functioning is guided by the esteemed 'Governing Body' and the 'College Development Committee,' both entities ensure the smooth operation and development of the institution.

Located in the heart of Latur city, the college occupies a spacious building that provides an ideal environment for learning and growth. Since its formation, the college has experienced remarkable progress. Starting with a modest enrollment of 41 students in 2012, it has grown substantially. In 2019 college has started PG i.e MCOM and PGDTL in the academic year 2021-22.

The college strongly advocates for gender inclusivity, as evident by the presence of remarkable number of female students. This commitment to equal opportunities and a supportive learning environment is reflected in the college's mission to empower students and provide them with the necessary tools for success.

Furthermore, the college extends its educational offerings to postgraduate studies. It offers a Master of Arts (M.A.) degree program in 11 subjects through distance education mode, enabling students to pursue advanced knowledge and specialization.

With its dedication to academic excellence and a student-centric approach, Govindlal Kanhaiyalal Joshi (Night) Commerce College continues to play a vital role in shaping the educational landscape of Latur. By providing educational opportunities to those who face barriers due to employment or self-employment, the institution strives to empower students and contribute to their personal and professional growth.

Our rural-based working youths faced obstacles that led them to abandon education due to personal, financial, or family reasons. With a deep-seated vision, our founders envisioned establishing an institution in Latur to: Empower socially and economically deprived working students, encouraging them to pursue higher education and achieve academic excellence through night college attendance.

1.3 CRITERIA WISE SUMMARY

Curricular Aspects

The College, established in 2012 and accredited by NAAC with **C grade** in Cycle One It is affiliated to Swami Ramanand Teerth Marathwada University Nanded and recognized institute under 2 F. The institution offer one Undergraduate Programmes: B.Com. There is one PG programme (MCOM) and one post graduate diploma course in Taxation Law (PGDTL) . There are **02 research supervisors** in commerce.

The college follows the **100% CBCS** at UG and PG level. The effective curriculum delivery ensures the holistic development of students by sensitizing students to cross-cutting issues such as gender, environment, sustainability, human values and professional ethics through its curricular and co-curricular activities.

The students undertake project reports as well as participate in quizzes, competitions, debates, mock-interviews, workshops and seminars to develop their academic skills.

Certificate Courses like Gandhi Vichar Sanskr Pariska, and soft skill development are available which offer academic flexibility to the UG and PG students.

Academic mechanism of UG and PG courses include experiential learning through **project work/field work**. Project and fieldwork was completed by 64 students (31.37 %) in the latest completed year.

The **feedback on curriculum** is regularly collected, analyzed and the suggestions of the stakeholders are placed in front of higher authorities for further action.

For the smooth and effective delivery of the curriculum, the College follows a systematic academic policy and planning in co-ordination with the IQAC for preparation of academic calendar and timetable, departmental meetings, assignment of workload, academic diary and use of ICT.

Teaching-learning and Evaluation

The admission process of the college is a transparent system complying with the directive principles of governing authorities.

Currently, the College has 2 full time Assistant Professor, 4 Assistant Professor are appointed by Management on contract basis and rest of the teaching staff is working under Clock Hour Basis(CHB)

The total intake capacity of student is 600 where as average enrollment is 58.88%

- The College monitors the achievement of Programme Outcomes (POs) and Course Outcomes (COs). the POs and Cos of the relevant Programme of the College are assessed through direct and indirect methods.

The **IQAC reviews the teaching learning** and evaluation through various quality initiatives. The initial assessment of students' learning levels through the basic test of competence, previous exam performance and teacher observance.

The **ICT tools** for learning are inevitable in the context of COVID-19 pandemic and they have made learning more individualized, creative and dynamic.

Quality Teacher Profile is our institutional distinctiveness in terms of their qualifications, characteristics, experience, availability, up-datedness and recognition of teaching abilities.

Student Satisfaction Survey is a direct indicator of the effectiveness of teaching learning in the college enabling identification of the strengths of teaching as well as the possible improvements.

Research, Innovations and Extension

The 'Research Culture' in the institution is consistently developing owing purposeful

attempts in this regard. College principal and other teachers personally work for developing research aptitude among students. College constitute dedicated committee for research and project based activities. Required resources like computer lab with internet facility, Ph.D thesis, reference books and periodicals are made available to students and teachers on the campus for undertaking research.

The college has entered into the **functional MOUs and collaborations** with different institutions. College try it level best to impart its social responsibility through various activities and cells like NSS, *Yuvati Kalyan Mandal* towards community issues, gender disparities, social inequity etc. and in inculcating values and commitment to society.

Affiliating University, Swami Ramanand Teerth Mathwad University has approved 65,000/- as a grant for Minor Research Project of College in-charge principal Dr. Sujata Chavan

Currently 100 % permanent teachers are **recognized research guides** of the affiliating university for Ph D.

The teachers published 25 **books and chapters** in edited volumes and papers published in conference proceedings and 41 research papers in journals during the last five years.

Total 42 Extension activities are carried out in the neighborhood community, sensitizing students to social issues, for their holistic development, and impact thereof during the last five years.

The college has 5 **functional MOUs** with institutions, other universities, industries, corporate houses etc. during the last five years.

The college provides support in terms of financial, academic and human resources required to submit research proposals and attend conferences, seminars and membership of professional bodies. The college conducts workshop/seminars on Intellectual Property Rights (IPR) periodically.

The research festival 'Avishkar' activities are funded by the college to encourage academic research aptitude among the students. The essential research facilities like books, computer, internet, equipment and space are provided by the college.

Infrastructure and Learning Resources

The college is located on the land of 5 acres comprising open space for two playgrounds, open auditorium, conference hall and garden. The adequate infrastructural facilities are available and augmented on regular basis. Library is considered to be the heart and soul of any Institute of Learning. It provides a meaningful avenue for collecting knowledge to enhance the quality of individuals, society and nation. As all the planets revolve around the sun and get essential energy from it, our Library also is a source of intellectual energy for all the Departments of the College.

The college is committed to provide required and sufficient infrastructural facilities for the smooth conduct of curricular, co-curricular and extracurricular activities on campus.

Maintenance and repairing of IT infrastructure such as computers, internet facilities including Wi-Fi and broadband is done through outsourcing.

Departments of Commerce and Language, cultural, sports cell have separate working space for office with adequate infrastructure.

Student Support and Progression

Student support facilities of our college facilitate students' holistic development and progression in curricular and co-curricular aspects of students. Facilitating mechanisms like placement cell, grievance redressal cell, Anti-ragging Committee, library, sports and extension activities facilitate vertical movement of students from one level of education to the next higher level or towards gainful employment.

Students are benefited through scholarships, freeships sponsored by central and state government and the college. The College has constituted Grievance Redressal Cell (examination, ragging, sexual harassment etc) which is proper functioning to redress the grievances.

Capacity building and skills enhancement initiatives taken by the institution include the Soft skills, Language and communication skills, Life skills (Yoga, physical fitness, health and hygiene) and ICT/computing skills.

The College has a transparent mechanism for timely redressal of student grievances including sexual harassment and ragging cases.

The Competitive Exams Guidance Cell, Remedial Coaching services are rendered to the students. The annual social gathering is a hub for the students to come out with all their dormant skills by participating in all the activities and learning several skills.

The registered Alumni Association contributes financial and non-financial ways for the development of the

college. Effective mentoring is beneficial for students. Brilliant records in games, sports, cultural activities, research festivals, academic, debates, elocution competitions, NSS have encouraging impressions on the other students.

Governance, Leadership and Management

The Curriculum Delivery Mechanism mainly includes three process:

- 6) The **student centric teaching methods** such as -Projects, Group Discussion, Mock-interviews, seminars, quizzes etc are used by the faculty. Faculty members integrate classroom teaching with the use of ICT tools and Innovative practices while teaching.
- 7) The Curriculum delivery processes comprise the activities of cross-cutting issues, add on courses, experiential learning, robust formative evaluation. Extracurricular activities, sports for holistic development, review and feedback etc.

C) Curriculum Review and Adjustment:

- 8) The IQAC regularly reviews the teaching learning process and it's adherence to the academic calendar through the syllabus completion reports. The **feedback on curriculum** is collected from the stakeholders and analyzed to bring out the suggestions on the curriculum.

Mechanism of Internal Assessment:

The internal examination Cell and IQAC plan, implement the internal assessment process according to university norms. The tentative dates of the unit tests and seminar, assignments are communicated to the students through the notices.

Transparency Measures:

Continuous Internal Evaluation sheets are provided and semester wise Plan of internal assessment are communicated to the faculty through meeting.

Teachers initially communicate in the classroom the weightage and the process of continuous internal evaluation.

Principal, in-charge of internal examination cell look after the grievances related to the CIE. Students who are unable to attend internal exams due to participation in sports, cultural events or personal valid reasons, are given opportunity to reappear for internal tests.

The results of all the internal examinations are discussed with the students.

Robustness Measures:

Assessment practices are conducted and undertaken ethically by faculty and students. Minimum two unit tests are held along with assignments, seminar, tutorials etc.

Evaluation tools like attendance, timely submission of assignments, active participation in class as well as curricular and extracurricular activities are taken into consideration for justified evaluation of students.

Prevention of mal practices in examination halls is also ensured by the vigilance of internal squad. Principal and head of CIE cell look after effective monitoring and timely implementation of the internal examination and evaluation. Question paper setting and evaluation are carried out by the respective subject teacher as per the guidelines provided by university.

There are other variety of assessment tools like Viva Voce for Project Reports, home assignment, oral test, group discussion, question bank, presentations, preparation reports etc.

Marks of the internal examination are communicated to the students and teachers discusses the assessed answer sheets with the students. There is a Grievances Redressal Cell to deal with the complaints regarding the CIE.

Thus, the internal assessment mechanism of the college is transparent and robust in terms of frequency and variety.

Mechanism for Examination Related Grievances:

University Related Grievances:

In case of any university related grievance, applications in prescribed Grievance Redressal forms are collected and forwarded to the University. The grievances of the students related to examinations such as under marking, queries related to hall ticket viz. correction in name/ subject, wrong entry of marks and absentee etc. are addressed at college and university level in time-bound period.

Students can apply for photocopy within prescribed time after the declaration of the result .University provides **photocopy of the assessed answer sheets** to students on demand after receipt of such application.

On receipt of photocopy of answer-sheet, the student consults with the respective subject teacher and takes his/ her opinion and then further processesfor **rechecking and revaluation**.

CIE Related Grievances:

Internal assessment is a continuous evaluation process. Any grievances regarding CIE are immediately resolved by the **respective teacher, head of internal evaluation cell and the principal**.

Grievances related research project work of PG students are resolved by the research coordinator and the headof the institution.

Continuous **follow up** is taken with the university till the grievance is settled. Examination related grievances are received and resolved in a specific time by the concerned authorities.

A)Infrastructure and Physical Facilities for Teaching- learning:

College is running in rented campus but as per the contract with land owner institution can use entire infrastructure and equipment's according to the need. Total area of the institution is 5 acres out of which built up area is 1220.745 Sq.M. In other words the college has authority to use all available facilities for teaching-learning and extra-curricular activities, which are regularly maintained with established mechanisms and augmented as per the requisitions.

B)Classrooms:

For conducting regular classes college uses 08 classrooms, 1 room for library, 1 reading room, 1 department office, 2 administrative rooms, one staff room and one ladies room in the college. The classrooms are provided with facilities like fan, tube-lights, benches and other required facilities. One classroom has the capacity of 60 students each.

C)Laboratories:

College has one well equipped computer lab having 10 computers with internet facility. College students and teachers use this lab for their academic and research activities.

D)ICT and Other Equipment:

There is well-equipped seminar cum ICT cum seminar hall. College teachers use LCD projector to deliver study material through Power Point Presentation. College administrative unit has 7 computers and one Laptop including personal computer in principals' cabin. There are three printers and one scanner in the office. College campus is provided with Wifi with 40 mbps capacity. During corona epidemic college continue its teaching through Zoom and team app. College has three tripod to install mobile to conduct online classes.

E)Facilities for cultural and sports activities Yoga centre, games (indoor and

outdoor) Gymnasium, Auditorium etc.

IT Facility

1. On the basis of changing pattern in the field of higher education and to cope up advancement in teaching learning process college is continuously engaged in improving its IT facilities.
2. During the COVID-19 pandemic all teachers had to adopt online teaching techniques in order to have uninterrupted teaching learning process. All teachers have delivered their lectures form their houses using various application like Zoom, Google classroom and Team app etc.

3. One Week Online Faculty Development Programme was arranged for teachers using Google meet. 52 Faculty members were participated throughout the state and 08 prominent academicians have delivered their experts on various academic issues using the Google meet app.
4. Internet and WI-FI facilities were improved gradually up to 40 mbps.
5. LCD projectors are available in the college used for presentation in various occasions including classroom teaching.
6. Online feedback system is introduced for feedback on curriculum, teaching learning which is analyzed and used for improvement.
7. Almost 100% teachers started delivering their lectures and successfully handling Zoom, Google Meet, etc. For Online Teaching, Class wise WhatsApp groups of all the college students are made. Daily online class link was shared to the students. The weekly report of the online teaching was submitted to principal. This practice helped to bring back on the track the teaching-learning activities during COVID-19 pandemic.
8. College had also conducted online internal examination of all classes using Google form.
9. As per the direction of parent university, Online viva of Final year students was also arranged.
10. In Collaboration with Parent University, Online examination for final year students were arranged during corona pandemic.
11. The college has an official website that was created to provide students with all kinds of academic support. The website proved helpful for students by extending access to various resources and necessary links.
12. The college gets all required services from its IT partner Shri Ramdev Computers, Latur including regular maintenance, repairs and up gradation.
13. College uses online working system for submitting internal marks, eligibility details of students, various reports etc required by parent university and other authorities time to time.

6.4 Financial Management and Resource Mobilization

6.4.1

Institution has strategies for mobilization and optimal utilization of resources and funds from various sources (government/ nongovernment organizations) and it conducts financial audits regularly (internal and external)

Response:

The institution transparency in financial management of the institution by conducting regularly external financial audit. The institution ensures that income and expenditure of the institution are subjected to regular external audit. Annual budget and audit system is the regular system of the college. The Institution prepares the budget every year by taking into consideration of recurring and nonrecurring expenditures. All these financial transactions are properly analysed and verified by the Principal, Sr.Clerk. The bill payments are passed after checking & verification of items or services. Only appointed authorized persons of the institution operate the transaction through bank, online mode. Transparency is maintained throughout the entire process and allocated funds are optimally utilized. Our College is affiliated to Swami Ramanand Teerth Marathwada University, Nanded and it is recognized with UGC 2F, Self-Financed institution. All the transactions and expenditures on recurring or non-recurring incurred through the banks, online transactions mode, cheques and vouchers.

The budgetary resources of the College include N. S. S. grants, scholarship grants are received from State and Central Government. Admission tuition and other fees are collected by the College from students and Alumni Contribution for the College development. In case of urgent financial needs, the institution requests Parent Institution (Shri Harihar Pratishtan) for financial support.

External Audit:

The external audit takes place annually after the completion of every financial year. The Chartered Accountant, who works as an auditor is appointed by Shri Harihar Pratishtan. All financial statements up to current year 2023 have been certified by the CA (Shinde Chavan Gandhi & Company). The nature of the payment is categorized into Revenue Expenditure and Capital Expenditure. This is also checked by the auditor. The bills and vouchers of the revenue expenditure is checked.) All the past Audit Reports are available at the college with its compliance reports. The Financial Audit of NSS Unit is done by the

CA appointed by Shri Harihar Pratishtan.

The Mechanism for Settling Audit Objection:-

After the completion of the college audit by the external competent chartered accountant. They submit their audit report to the Institute. The Institute submits this report to the college for compliances. The audit report is discussed in the GB Meeting and College Development Committee (CDC) of the college. However, no major audit objections are noted by Auditing Agencies till date. The compliance of minor queries is fulfilled.

6.5 Internal Quality Assurance System

1. Gender equity:

The composition of this institution itself is an example of gender equality as the responsibility of two core positions at parent institution i.e. President and Vice-President are chaired by Women. Even at institution level, important posts like Principal, Head of the Department and library are handled by women staff. Out of seven criteria for NAAC assessment, the responsibility of four criteria are handled by women. Total numbers of teachers working in the institution adds up to 19, out of which there are 10 women teachers.

Even being a night college, institution tried to seek maximum admission of girl students. Principal and faculty personally counsel girls' parent about the safety and security measures. For example women's room, on call Damini Police Squad etc.

According to the motto of the college "**Dnyanam Param Dheyam**" the doors of knowledge are open for men and women equally.

College Development Committee decided to give 10% concession in the admission fees for girl students in order to encourage more admission of girl students.

Along with this textual syllabus, various cell and departments arrange essay competition, guest lecturers, group discussion, debate etc. based on gender equality.

celebrated by NSS and other units. College also celebrate special days like International Women Day, Daughters Day to generate a sensitive approach towards women.
